MINUTES - REGULAR SELECTBOARD MEETING

TOWN OF BARNET, VERMONT

MONDAY, SEPTEMBER 26, 2022

Meeting convened at 7:02 p.m. in-person at Barnet Fire & Rescue Station (151 Bimson Drive) and via GoToMeeting telephone/online conference. This meeting was recorded via GoToMeeting.

Board members participating in-person: Dylan Ford (presiding co-chair), Benjamin Gates, and Mark Jefferson.

Other Town officials and employees participating in-person: Town Attorney Steven Adler, Road Foreman Mark Chase, Lister John Fairchild, Town Clerk Benjamin Heisholt, Fire Chief Ronald Morse, and Zoning Administrative Officer Shirley Warden.

- 1. Consideration of approval of minutes of regular meeting held September 12, 2022
 - Mr. Gates moved to approve as presented the minutes of the regular meeting held September 12, 2022. Seconded by Mr. Jefferson and approved by voice vote.
- 2. Other business presented by members of the public
 - a. Resident Eric Skovsted regarding noise disturbance on Brook Hill Road
 Mr. Skovsted of Brook Hill Road appeared and read a prepared statement regarding
 harassment and noise disturbance he alleges has been directed towards his family by a
 neighbor on Brook Hill Road. The statement does not request any specific action by the
 Board. The Board noted that it has discussed this ongoing matter in the past. Discussion
 ensued regarding consideration of adoption of a noise ordinance.
 - b. Harvey Mountain Road highway access

Steven Adler reported that a the highway access of a residence on Harvey Mountain Road has a steep drop from the road pavement to driveway surface.

- 8. Consideration of, and take any action on, correspondence from Vermont Natural Resources Board regarding Act 250 Minor Notice and Draft Permit for project on Keyser Hill Road

The Board noted that the Natural Resources Board had retracted this notice because it had been distributed prematurely.

Section 313 (a)(1)(F), that premature public knowledge of discussion concerning a tax appeal to Superior Court by Great River Hydro LLC would clearly place the Town of Barnet at a substantial disadvantage. Seconded by Mr. Jefferson and approved by voice vote.
- Mr. Gates moved that the Board enter executive session pursuant to 1 V.S.A. Section 313 (a)(1)(F) to discuss a tax appeal to Superior Court by Great River Hydro LLC, as premature public disclosure of which would clearly place the Town of Barnet at a substantial disadvantage. Seconded by Mr. Jefferson and approved by voice vote. Entered executive session at 8:09 p.m. Those present in executive session: Ms. Ford, Mr. Gates, Mr. Jefferson, Town Attorney Steven Adler, and Town Clerk Benjamin Heisholt.
- Mr. Gates moved to exit executive session. Seconded by Mr. Jefferson and approved by voice vote. Exited executive session at 8:51 p.m.
