EXPIRATION DATE: Approved projects not started within 24 months from date of issuance is void, and reapplication is required. Re-application will be subject to bylaws in effect at that time.

INSULATION CERTIFICATION: An Energy Code Certificate is required by 30 V.S.A. Subsection 51 (residential building energy standards) or 53 (commercial building energy standards) for all new heated or cooled construction including additions, alterations, renovations, and repairs. DRIVEWAY PERMITS: A Barnet Driveway Access Permit and a 911 address may be required.
